

## ORDER OF AN EXECUTIVE OFFICER UNFIT FOR HUMAN HABITATION ORDER TO VACATE

To: Andrew Chen

"the Owner"

And To: All Occupant(s) of the following Housing premises: 6236 18 Street SE – Garage

**RE:** Those housing premises located in Calgary, Alberta and municipally described as:

6236 18 Street SE - Garage

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The detached garage was being used for sleeping and living purposes. An individual was observed to be sleeping in the garage. Personal belongings such as clothing, bedding, and food was present in the garage. A couch was set up and layered with bedding and a pillow for sleeping purposes. The floors, walls and ceiling of the garage were unfinished. The garage had no plumbing, no kitchen, and no washroom facilities.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

a. The detached garage was being used for sleeping and living purposes. An individual was observed to be sleeping in the garage. Personal belongings such as clothing, bedding, and food was present in the garage. A couch was set up and layered with bedding and a pillow for sleeping purposes. The floors, walls and ceiling of the garage were unfinished. The garage had no plumbing, no kitchen, and no washroom facilities. This contravenes section 5(2) of the Housing Regulation, 2001 which states that: No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the occupants vacate the above noted premises immediately.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Immediately cease allowing the use of the garage for sleeping and /or living purposes until such time as the garage is brought into full compliance with the Minimum Housing and Health Standards.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
