Provincial Advisory Council Goals	<p>The Council will receive regular updates and overview of progress from the Provincial Executive Leadership and the AHS Board to ensure we are best serving our cancer patients, caregivers, and their families.</p> <p>The Council commits to:</p> <ul style="list-style-type: none"> • Build awareness of the Council’s roles and responsibilities to the public. • Provide a vehicle for patients, families, and communities to identify existing and emerging cancer healthcare issues that can be shared with AHS program leadership and AHS Board. • Provide opportunities for AHS to work with the Council to share information about AHS cancer services and programs with communities. • Provide advice to AHS on ways to improve quality, access, and sustainability of cancer services in Alberta.

Information Sharing	<p>The Cancer Provincial Advisory Council has a role to provide and share information through each member’s respective networks. As such, the Council commits to share information including but not limited to the following:</p> <ul style="list-style-type: none"> • Promote ongoing AHS cancer campaigns, such as “listen to your body”, encouraging and bringing awareness of regular cancer screening (e.g., FIT testing) by expanding and extending the reach of the campaign through social media and other virtual means until in-person opportunities open up. • Share resources (i.e., posters) through our networks. • To support and act as a liaison for local cancer care initiatives in our communities that can improve the lives of those affected by cancer. Support community-driven initiatives/ideas. • Commit to sharing information by presenting to Health Advisory Councils, Provincial Advisory Councils and Wisdom Council (i.e., joint session or invite AMH PAC to Cancer PAC meeting), addressing misinformation and speaking to the evidence-informed science. • Supporting Albertans living with cancer by sharing information on how to navigate the system and get the information they need. • Share and promote resources for those transitioning from Cancer Care Alberta (i.e., youth to adult system, acute to community treatment, shift to palliative care) 	2022-2023

Engagement	<p>The Cancer Provincial Advisory Council membership recognizes that while they do their best to represent Albertans living with cancer, bringing more voices to the conversation is important. The Council commits to engaging Albertans by:</p> <ul style="list-style-type: none"> • Bringing the community voice back to Cancer Care Alberta, potentially through partnership engagement opportunities with Health Advisory Councils. • Building trust, cultural safety for Indigenous and other population groups living with cancer. • Engage other Advisory Councils to seek community-based information and ideas. • Being available to support cancer care engagement on key initiatives and services. • Identifying opportunities to engage Albertans on topics such as the financial, psychosocial, and caregiver’s needs, etc. that contribute to quality of life. (i.e., partnership / connection with agencies such as Wellspring). • Engage Albertans in conversation on emerging issues or opportunities (i.e., opening of the Calgary Cancer Centre). 	2022-2023

Council commits to:</p> <ul style="list-style-type: none"> • Seek to understand the journey through cancer care and provide input based on lived experience. • Seek to understand how Cancer Care Alberta hears from patients and measures quality of care (i.e., patient-reported outcomes, patient surveys, etc.). • Provide input into: <ul style="list-style-type: none"> ○ New initiatives, programs, and services as appropriate and with evidence informed data. ○ Standards of care. ○ Access for all Albertans as close to home as possible. ○ Access to information and resources outside of urban areas. 	2022-2023
