

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Sweet T's Inc.

RE: The Food Establishment located in Calgary, Alberta and municipally described as:
106-310 4 Avenue NE – Food handling

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 exist in and about the above noted premises, namely:

- a. Operating without a valid and subsisting food handling permit from Alberta Health Services. Handling food in a location without prior approval from Alberta Health Services, Environmental Public Health. This contravenes section 3(1) (a) (b) of the Food Regulation 31/2006 which states that: no person shall operate a food establishment unless the person is an operator who holds a valid and subsisting permit for the operation of the food establishment, and the food establishment is identified on the permit as approved by the regional health authority that issued the permit.
- b. High risk food prepared at an unknown location and stored at the above unpermitted address was being retailed to permitted food establishments for resale.

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately cease food processing at the above noted premises.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Cease any and all food handling and food storage activities at unpermitted facilities. Discard all food processed or stored at any unpermitted premises.
3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of an Executive Officer of Alberta Health Services, the above noted premises shall remain closed for food production and storage.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
