

## ORDER OF AN EXECUTIVE OFFICER CLOSED FOR TENANT ACCOMMODATION PURPOSES ORDER TO VACATE

То:	Gordon Coxson "the Owner"	Gecko Holdings Ltd. "the Owner"	Ido Vandelaan "the Tenant"
And To:	All Occupant(s) of the following Housing premises:		
RE:	Those housing premises located in Edmonton, Alberta and municipally described as: Basement-Unit 2, 11425 95 Street T5G 1L3		

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. Via an entrance through the unit's kitchen, a storage room in the basement had been converted into a bedroom and being used for overnight accommodation. A child's bed along with children's bedroom furniture and an adult-sized couch bed were noted and both appeared to have been slept in. Clothing & bedding were noted throughout the basement storage room as well. No openable egress window or door that provides access directly to the exterior noted in the basement storage room.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

a. No openable egress window or door that provides access directly to the exterior noted in the basement storage room. This is in contravention of Section 3(b)(i)&(ii) of the Minimum Housing and Health Standards, which states "For buildings of 3 storeys or less and except where a bedroom door provides access directly to the exterior or the suite is sprinklered, each bedroom shall have at least one outside window which may be opened from the inside without the use of tools or special knowledge. (ii) Windows referred to in section 3(b)(i) shall provide unobstructed openings with areas not less than 0.35 m2 (3.8ft2), with no dimension less than 380 mm (15")."

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed for Tenant Accommodation Purposes**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the occupants vacate the above noted premises on or before September 7, 2023

- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Remove all beds, bedding and accessories to overnight sleeping from the basement storage room and sign a room rental agreement that indicates the basement storage room cannot be used for overnight sleeping.

If the basement storage area is to be used for overnight sleeping purposes: Install a window a with a openable area that measures 3.8 square feet with no dimension less than 15 inches or install an door that provides direct access to the exterior of the building or install an approved sprinkler system.

3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed for tenant accommodation purposes.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
